The Clerk reported that invitations had been sent out to all residents who had shown an interest in joining a Neighbourhood Plan steering group to attend a meeting in the Community Centre with CEC Spatial Planning officer Tom Evans at 7.00pm on 26th February.

Improvements to ticketing arrangements

Northern Rail announced that new customer information screens would be installed at Disley station in the near future.

The Clerk reported that a subsequent request from Paul Spencer, Station Delivery Manager, for a meeting on 18th February to discuss further station improvements had been received.

Cllr. Kidd said that he had spoken with Phil Mason, CEC Senior Environmental Officer, and had agreed that it would be more appropriate for him to attend the next meeting of the SEMMMS/A6MARR sub-committee which it was hoped would be within the next few weeks.

All current or potential parking locations identified in the document were discussed and the following actions/updates were agreed:

Cllr. Davenport and the Clerk to pursue CEC Licensing to enable parking restrictions at the Community Centre car park to be enforced.
Meeting to be arranged with Mitchells & Butler to discuss potential public parking opportunities at the Ram's Head.

Clerk to obtain information on the Hazel Grove park and ride scheme from Stockport MBC.

Cllr. Kidd said that he would like to see more cycle rack provision in the village and it was agreed that this would be an issue raised at the meeting with Northern Rail on 18th February.

Clerk to update document for circulation to Councillors.
