

**MINUTES OF DISLEY PARISH COUNCIL PLANNING COMMITTEE MEETING
HELD ON WEDNESDAY 25th NOVEMBER 2015**

4076 **Public Forum**

A resident expressed her concerns, and those of many other residents, about the proposed change of use of the Plough Boy pub from A3 to C3 Residential (Planning Application 15/5185M).

The resident said that the Plough Boy had been a community hub for the Higher Disley area for many years, particularly for many of the elderly residents living in this area who were unable to access other facilities in the village. She said that in order to protect the pub steps should be taken to get the Plough Boy designated as an Asset of Community Value (ACV). She said that twenty one signatures were required in order to register the pub as an ACV and that this would afford a moratorium period of up to six months.

Another resident, a previous tenant of the Plough Boy, said that it had been a thriving, viable business which could have been sold as a going concern; he was aware that several offers had been made to the current owners for the business.

Cllr. Pattison thanked all the residents for attending and proposed that consideration of the Planning Application be taken out of agenda order to allow residents to hear Councillors' comments.

15/5185M Change of use from public house to single dwelling (A3 to C3) together with partial demolition and vehicle access for parking

Ploughboy Inn, 61, Buxton Old Road, Disley, SK12 2BN

Cllr. Pattison said that she was opposed to this application because it would result in the loss of an important village asset and that, in the absence of the Ward Councillor, was looking to get this application called in for determination by Cheshire East Council's Planning Committee rather than by officer delegation. This would give councillors and residents the opportunity to speak to the Committee directly to express their concerns.

All Councillors present were in agreement to oppose the application and support residents in their efforts to conserve the Plough Boy as a pub.
